CORRIGENDUM

Two Part Tender for the supply of Poly End Film for the year 2017-2020

The following amendments are hereby made in the tender documents for the supply of Poly End Film for the year 2017- 2020:

Technical Bid

- 1. In the tender clause 5.5.6, for the expression "Fifteen clear days", the expression "Fifteen clear days excluding holidays" shall be substituted.
- 2. In the tender clause 7.9, for the expression "The tender estimated value of Rs.1,63,778/- per M.T. of poly end film", the expression "The tender estimated value of Rs.1,31,050/- per M.T. of poly end film".
- 3. As per the amendment of Tamil Nadu Transparency in Tenders Act, the tender clause 9.4, 9.4(i) and 9.4(ii) may be substituted as follows:
 - 9.4 The evaluation shall include States Goods and Services Tax, Central Goods and Services Tax, Integrated Goods and Services Tax and all central duties such as customs duty as a part of the price, as detailed below:-
 - i) In evaluation of the price of an imported item, the price has to be determined inclusive of the customs duty.
 - ii) In evaluation of the price of articles which are subject to States Goods and Services Tax, Central Goods and Services Tax, Integrated Goods and Services Tax, the price has to be determined inclusive of such States Goods and Services Tax, Central Goods and Services Tax, Integrated Goods and Services Tax.

- 4. As per the amendment of Tamil Nadu Transparency in Tenders Act, the tender clause 9.4(iii) and 9.4(iv) is omitted.
- 5. TENDER INFORMATION(Page No.5, SI. No.iii) may be read as follows:

- 6. The tender clause 4.8 and 4.8.1 may be read as follows:
 - 4.8 GST REGISTRATION CERTIFICATES:
 - 4.8.1 Tenderers shall furnish photostat copies of valid GST Registration Certificates along with the tender.
- 7. The tender clause 4.12.2 may be read as follows:
 - 4.12.2 The end price of film shall take into account the Input Tax benefits/credit available in the price of granules.
- 8. The tender clause 4.12.3 may be read as follows:
 - 4.12.3 Price revision of Poly end film will be given effect to as and when the Reliance Industries Ltd. revises the price of granules. In the upward revision of prices of granules by Reliance, the Input Tax credit available in the increase in the price of granules should be fully adjusted in the corresponding increase in GST payable on the poly end film. In the downward revision of the price of granules by Reliance the relief in the GST on the poly end film after adjusting the Input Tax fully

shall be passed on, in the end price of film to the benefit of the Federation.

- 9. The tender clause 4.12.4 may be read as follows:
 - 4.12.4 Similarly the GST credit to be passed on in the end price of film to the benefit of the TCMPF Ltd. in the event of upward or downward revision of the price of granules.
- 10. In the tender clause 5.3, for the expression "For 200ml, 250ml & 500ml pouch: 54 Mic. ± 7.5% White Opaque", the expression "For 200ml, 250ml & 500ml pouch: 63 Mic. ± 7.5% White Opaque" shall be substituted.
- 10a. In tender clause 5.5.1, for the expression "single colour/two colour/three colours", the expression "**three colours**" shall be substituted.
- 11. In the tender clause 6.3.2, for the expression "54 Micron ± 7.5% for 500ml film", the expression "63 Micron ± 7.5% for 500ml film" shall be substituted.
- 12. The tender clause 6.5.1 may be read as follows:
 - 6.5.1 If the thickness of the multi-layer film is not within the ranges viz.,
 - 63 Micron ± 7.5% (Range from 58 mic to 68 mic) and 110 Micron ± 7.5% (Range from 102 mic to 118 mic), as observed at the time of testing the random samples, the entire consignment will be rejected. No Deviation on the upper/lower

limit in the above said ranges of film thickness will be allowed.

13. The tender clause 6.5.2 may be read as follows:

6.5.2 Required yield and other specifications are mentioned below per Kg. for white opaque film.

Width of Pouch = 301 ± 1 mm.

For 5000ml = $590 \pm 2mm$

Length of Pouch = for 200ml -100mm

for 250ml - 110mm

for 500ml - 155mm

for 1000ml - 240mm

6.6.1 If the yield per kg of consignment is less than the minimum quantity prescribed below shall be rejected. The tenderer will be informed about the rejection of the consignment within 15 days of receipt of the consignment.

For Example: For yield of 500 ml sachets 63 microns ± 7.5%

16. The tender clause 7.10.1 may be read as follows:

7.10.1 Each tender should be accompanied with Two Nos. of three colour printed samples with any design, in not less than 5 Kgs. in weight in the category micron film tendered for 63 Micron 500ml – two samples, 63 Micron 1000ml – two samples & 110 Micron 5 litre – two samples in not less than 10 Kgs. in weight thus coming to totally six in opaque white pigmented only. Tender sample roll should be printed with the name of the manufacturing firm so as to identify the company sample without this, the tender will be rejected. The tenderer who has downloaded the tender documents can receive the samples from this office on request. The tenders received without samples will be summarily rejected.

17. The tender clause 7.10.2 may be read as follows:

7.10.2 Width of the film shall be 301mm \pm 1mm for 63 micron 500ml & 1000ml packing and 590 \pm 2mm for 110 micron for 5 litre packing.

18. The tender clause 7.10.3 may be read as follows:

7.10.3 Testing of sample will be carried out as indicated below:

500ml Packing: 63 Microns 1000ml Packing: 63 Microns 5000ml Packing: 110 Microns

19. The tender clause 7.10.4 may be read as follows:

7.10.4 The samples will be tested at M/s. CIPET (or) Indian Institute of Packaging (or) MIT, Anna University (or) National Test House, Chennai for 40:60 LDPE & LLDPE (OCTENE and Mettalocene) combination parameters (LDPE 40% and LLDPE 60% (OCTENE 40% and Mettalocene 20%). The following parameters will be tested by the above agency. The test results given by the agency will be the basis for selection/rejection of tenders. Only such of those samples conforming to the Technical parameters in the testing will be considered for the next level of factory testing at the Metro Dairies.
