TERMS AND CONDITIONS

1. This tender is invited for printing and supply of approximate quantity of 1.50 crores milkcards for one year for 2019- 2020 i.e 12.50 lakhs per month printing in 200 GSM thickness maplithone paper with Length 10 cm x Breadth 10 cm size with Multi colour and Alpha Numerical.
2. The Tenderer should have own or leased Security Press with Alpha Numerical printing facility.
3. This tender is invited, subject to the provision contained in the Tamilnadu Transparency in Tenders Act 1998, Tamil Nadu Transparency in Tender Rules 2000 and 2012 as amended up to date.
4. All the columns in the Tender documents and schedules should be filled in and no column should be left blank.
5. The Tender documents with required details with two parts should be enclosed in a sealed cover addressed to the General Manager (Mkg), TCMPF Ltd, No.3-A, Pasumpon Muthuramalinganarsalai, Nandanam, Chennai-35 before the due date and time.
6. It is hereby informed that TCMPF shall not accept any deviations on conditions stipulated by the Tenderer. Tenders should be in total conformity with the TCMPF specifications & the Tender conditions lest the tenders are liable for rejection.
7. Tender Documents shall not be received after closure of the Tender Box.
8. Each tender should be enclosed with an EMD of Rs.123,000/- (Rupees One lakh and twenty three thousand only) in the form of DD drawn in favour of TCMPF Limited, Chennai payable at Chennai. Failure to the above, the tender will be summarily rejected.
9. Any Tender claiming exemption from the payment of EMD :
 - a) Shall enclose a copy of the acknowledgement obtained from the General Manager, District Industries Centre concerned for filing of the Entrepreneurs Memorandum Part-II, in respect of items manufactured by them for which tenders have been called for alone will be granted exemption from payment of EMD.
 - b) In respect of SSI units located outside the state (Tamilnadu), such of these units registered with NSIC in respect of items manufactured by them for which the tenders have been called for alone will be granted exemption from payment of EMD.
10. If the tender is submitted through e-tendering, then the EMD should be dropped in the tender box before the closure time.

SIGNATURE OF THE TENDERER

11. In case, for any reasons, the Tenderer withdraw the tender, at any stage, during the period of contract, the Joint Managing Director reserves the right to forfeit the EMD and S.D. in part or full. EMD to the unsuccessful tenderers will be refunded after the tender is finalized.
12. The successful tenderer shall pay the Security Deposit of 5% of the value of the order placed inclusive of EMD paid, as a guarantee of the tenderer to the performance of the contract, in the form of D.D.
13. The awarding of tender is subject to inspection of the firm by the Joint Managing Director or by his authorized representative at any time.

14. LEGAL JURISDICTION:

a) The successful tenderer shall become an Associate Member of TCMPPF Ltd. by paying the requisite fees under the Tamilnadu Co-operative Societies Act & Rules.

b) If either party is in any way aggrieved, either party has the right to raise dispute by way of Arbitration under Section 90 of the Tamilnadu Co-operative Societies Act before the Dy. Registrar (Dairying)., Thiruvallur whose decision shall be accepted as final.

c) In case of litigation, the relevant court in Chennai alone will have jurisdiction.

14. The Federation shall issue 30 days notice to the successful tenderer for premature termination for violation of terms and conditions and Agreement clauses.
15. The successful tenderer should supply the additional requirements upto 25% of the tendered quantity at the same rate agreed in the Tender negotiation as per the TT Act.
16. The tenderer should hold the prices valid for 120 days from the date of opening Technical Bid. Tenderer shall give extension of validity period if requested by the Federation.
17. On confirmation of the Tender, the successful Tenderer should execute an agreement with the Federation (Rs.100/- non-Judicial Stamp paper) for the due and faithful performance of the contract at the approved tendered rates which shall be valid for 12 months from the date of execution of Agreement.

18. PRE QUALIFICATION:

- A. This Tender is floated with Two cover system (i.e) Technical bid cover and Commercial bid cover. Technical bid cover will be opened first and will be evaluated. The Commercial bid of the tenderers who have qualified in the Technical bid only will be opened. The samples of **maplithone paper** submitted by the Tenderer shall be tested by the Federation. If it is found that the thickness of the board is lesser than **200 GSM**, they will not be considered eligible for Commercial Bid cover.
- B. The tenderer should have owned or leased security press with Alpha Numerical printing facility.
- C. The tenderer shall have average annual sales turn-over for the last three financial years equal to the tender estimated value AND minimum annual sales turn-over in each of the last three financial years shall not be less than 50% of the tender estimated value.

19. PAYMENT TERMS:

Payment shall be released on receipt of the supply of milkcards as per Technical Specification at site.

20. VALIDITY:

- 1) The tender shall be kept for acceptance for a period 120 days from the date of opening of Part I Technical bid. The offers with lower validity period are liable for rejection.
- 2) The tenderer shall agree to extend the validity of the bids without altering the substance and prices of their bid for further period, if any required by Federation.

21. VIOLATION OF CONTRACT:

- 1) Not withstanding anything contained in the tender schedule, no obligation is cast on the Federation to accept the lowest tenderer and the Federation shall also have the right to accept or reject the tender without assigning any reasons.
- 2) For violation of any of the terms and conditions of the contract, the Federation reserves the right to terminate the contract with or without notice, as applicable.
- 3) In the event of termination of contract, the SD will be forfeited and any of the resultant loss shall be recovered from pending bills.

- b) The rate should be inclusive of all with breakup details, GST and FOR Chennai.

23. The rate quoted should be inclusive of all cost of delivery at final destination such as transportation, Payment of duties and tax leviable, Insurance and any incidental and giving break up thereof.

24. Due to administrative reason, circumstance warrant, the Tenderer should continue the printing and supply of the Milk cards at the approved Tender rate for the time extended by the Federation beyond the expiry of the contract period (i.e) 25% of the value of the order as per the TT Act.

25. The Federation reserves the right to terminate the Tender contract in case of exigency, without assigning any reason.

26. The successful Tenderer should supply the required quantity of milk cards every month appx. 12.50 lakhs cards within the specified period and quantity in 200 GSM thickness of maplitone paper with Length – 10 cm x Breadth – 10 cm size in multi colour colour with Alfa Numerical printing. The specimen copy shall be collected from our office along with Tender Documents (i.e) different type of cards with different colour and matter.

27. It is the responsibility of the Tenderer to print and supply milk cards as per the Tender conditions, General Conditions and Agreement clauses. Any violations will lead to the termination of the contract and forfeiture of the EMD. The milk card is equivalent to the cash, hence Security arrangements shall be made in the press and if any card is missing (or) theft of cards occurred after printing at their press, the cost of milk cards with penalty shall be recovered from their bill apart from taking legal action against the Contractor.

28. Packaging procedure:

The milk cards shall be bundled with 100 Nos. serially with rubber band and then bundled with 1000 Nos and again Bundled in 4000 Nos with Thread then 20,000 Nos. covered with polythene cover and it should be packed in 5 ply corrugated carton boxes for safety purpose and superscribed with each type of cards on the top of each Bundle separately with serial number. A certificate has to be furnished along with every consignment confirming the thickness of the card.

29. Penalty Clause:

It is the responsibility of the Tenderer to supply of milk cards with serial numbers starting with 000001 (both numerical and alphabetical) against all type of cards without omission or missing of cards. If any card found missing (or) number less cards, the printing cost would be recovered from the contractor bill in addition to penalty of 1% of the respective bill amount pertaining to the relevant delivery challan.

SIGNATURE OF THE TENDERER

- a) If milk cards are supplied beyond our schedule date, a penalty of Rs.500/- per day will be imposed on the Tenderer.
- b) Payment shall be made to the Tenderer after satisfactory completion of supply as per the specification and schedule within 15 days from the date of receipt of cards.
- c) If any increase or decrease in Statutory levies shall be borne by the Tenderer.

30. Specification

- a. The specification and other particulars to be incorporated on the milk cards rest with the Federation. And the contractor has no legal bindings for change of specification in any manner in respect of milk cards.
- b. If any modification or change of matter, colour and milk selling price etc. in the all type of milk cards, the expenditure involves for changing the Cylinder/ art work shall be borne by the Tenderer only.

31. EVALUATION:

- 1. The Tenders will be evaluated strictly as per the T.N. Transparency in Tenders Act 1998 and the T.N Tenders Rule 2000 and 2012.
- 2. The Tender offers received will be examined to determine whether they are in complete shape, all required data have been furnished, properly signed and generally in order and confirms to all the terms and conditions of the specification without any deviation.
- 3. For the purpose of evaluation of tender offers, the following factors will be taken into account for arriving the evaluation price.
 - a. The quoted price will be corrected to arithmetical errors.
 - b. In case of discrepancy between the price quoted in words and figures lower of the two shall be considered.
 - c. If the Tenderers are both from other States and Tamilnadu, the evaluated price will include GST, freight charges, insurance and any other charges.
